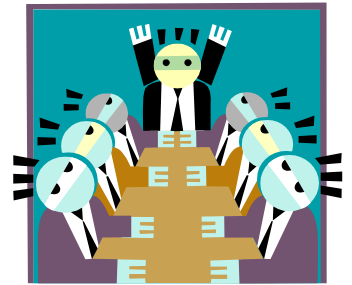
## 41st Annual Countryside Homeowner Association Meeting

### WHAT IS PROXY VOTING?

Proxy voting is a form of voting where a member of a decision-making body may delegate their voting power to another member of the same body who would vote in their absence. Most election and rule making guidance documents require a certain percentage of its members to vote in order for the election, or rule making guidance document to become valid. By submitting a proxy you state that the person you choose, on the proxy, is allowed to cast a vote for your in your absence. By not voting or submitting a proxy you reduce the possibility of someone being elected or new guidance policies being put in place. There are 475 homes in our community and it takes a vote of 10% to elect someone. Therefore, someone would need 48 votes to become elected. If you do not wish to vote with your proxy, please attend the Annual Meeting at 7:30 pm on February 21st and cast your vote in person.
